Executive Summary

This document updates the project's management procedures that apply to MOSES both from the administrative and financial perspective, as were described in Deliverable D1.7 MOSES Project Administrative and Financial Management Plan Rev1. The project management plan is a joint responsibility of all project partners until the complete discharge of all obligations under the European Commission (EC) Grant Agreement to guarantee transparency and commitment from all engaged partners and thus facilitate a successful delivery of project results and maximise the impact of MOSES. It assures that the project will meet its objectives on time, within the allocated budget and with outstanding quality results. The plan presented hereafter consists of planned and systematic processes and steps, schedule per task, responsible partner related subtasks, related deliverables, dependencies, Gantt chart and work breakdown structure, project bodies, communication and reporting. Moreover, it is going to be used to monitor the corrective actions employed to verify that agreed procedures are in place and are being adequately implemented.

This revised document considers the experience from the project's implementation since M18 and includes the following additions (compared to D1.7):

• Changes to work breakdown, schedule, and time management that resulted after the amended MOSES Grant Agreement that entered into force in June 2023.
